RECOMMENDED ACTIONS:

Second Reading to adopt an Ordinance amending the Annual Salary for Members of the Board of Supervisors.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

The Board of Supervisors' salaries are currently set at 41.2% of the annual salary for Superior Court Judges (SCJ). For Board Members who have commenced their sixth (6th) year of elective service, their salaries are set at 43.26% of SCJ annual salary. The last review of the structure used to set Board Members' salaries was done in 2018.

The recommended action for your Board's consideration, if adopted, will amend the annual salary for members of the Board of Supervisors as set forth below, and as reflected in the attached Ordinance:

For Board Members who have up to five years of elected service, the annual salary will be set at 50% of the annual salary for a Superior Court Judge. The amount will reflect an annual increase of \$20,343.

For Board Members who have six or more years of elected service, the annual salary will be set at 55% of the annual salary for a Superior Court Judge. The amount will reflect an annual increase of \$27,140 for those Board Members who meet the years of elected service requirement, which is currently two members.

FISCAL IMPACT:

The estimated cost associated with the recommended action is approximately \$38,437 for the remainder of the 2022-2023 Fiscal Year. The cost of the adjustment will be offset by currently projected salary savings and will be included in the subsequent fiscal years' proposed budgets.

CONNECTION TO THE COUNTY OF MADERA STRATEGIC PLAN - MISSION 2023:

This item is not defined in the Strategic Plan; the requested action is also not in conflict with any of the defined focus areas.
