WHEREAS, the Board has determined to delegate authority to the Chief of Development Services to execute all necessary documents for the Project and to approve the necessary expenditure of funds required for the Project.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Madera, a political subdivision of the State of California, that:

- 1. The Chief of Development Services, and his designee, are authorized to execute all agreements, accept all deeds, open and facilitate the close of all escrows, and execute all necessary documents, letters and certificates that are convenient or required to secure State and Federal approvals and to complete the acquisition of rights-of-way, easements and other interests in real property on and for the area shown on Exhibit "A," attached hereto.
- 2. The Chief of Development Services, and his designee, are authorized to execute all right-of-way certifications as may be required by CALTRANS for the Project.
- 3. The Chief of Development Services, County Auditor-Controller, and other County officials, and their designees, are authorized to expend all funds that are necessary to secure all State and Federal approvals and to purchase all rights-of-way, easements and other interests in real property necessary for the Project.
