

MADERA COUNTY CONTRACT NO. _____
(Amendment to Contract No. 11567-20 for Legal Services – Lozano Smith, LLP)

THIS AMENDMENT to AGREEMENT is executed in duplicate this ____ day of _____, 20 _____, by and between the COUNTY OF MADERA, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and the law firm of LOZANO SMITH, LLP, hereinafter referred to as "LOZANO SMITH."

RECITALS

A. The parties hereto entered into Madera County Contract No. 11567-20 on August 1, 2019, providing for legal services as described therein. Madera County Contract Amendment No. 11567A-20, clarifying only the fiscal year term, was entered into on November 10, 2020 (the "Agreement").

B. Section 13 of the Agreement allows for amendment of any part of the Agreement by the parties' mutual written consent.

C. The parties wish to further amend the Agreement as set forth below in this Amendment to the Agreement.

AMENDMENT

1. Paragraph 3, "Compensation", of the Agreement is amended to read as follows:

"COMPENSATION. COUNTY shall pay LOZANO SMITH on an hourly basis and reimburse costs as set forth in Attachment A. COUNTY shall have no obligation to compensate LOZANO SMITH in excess of the sum of One Million Five Hundred Forty Thousand Dollars (\$1,540,000.00) in any fiscal year during the term of this Agreement, not including LOZANO SMITH fees and costs that are reimbursable to the COUNTY from any other source."

2. Except as otherwise provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.



1. HOURLY PROFESSIONAL RATES

Client agrees to pay Attorney by the following standard hourly rate:

Attorney \$ 250 per hour

Law Clerk / Paralegal \$ 150 per hour

* No travel charge shall apply from the Lozano Smith Fresno office to the Madera County Government Center

2. BILLING PRACTICE

Lozano Smith will provide a monthly, itemized statement for services rendered. Time billed is broken into 1/10 (.10) hour increments, allowing for maximum efficiency in the use of attorney time. Invoices will clearly indicate the department or individuals for whom services were rendered.

Written responses to audit letter inquiries will be charged to Client on an hourly basis, with the minimum charge for such responses equaling .5 hours. Travel time shall be prorated if the assigned attorney travels for two or more clients on the same trip.
