RECOMMENDED ACTIONS:

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

Under the provisions of the CSAC Constitution, members of the Board of Directors and alternates are nominated by their respective Boards of Supervisors and appointed by the Executive Committee to one-year terms of office commencing with the first day of the CSAC annual conference. This year the conference commences on November 14, 2022. Any member of the Board of Supervisors is eligible for the directorship.

CSAC's Board of Directors holds its first meeting of each year at the Association's Annual Conference. Thus, it is important that Madera County has its newly appointed Board representative at the first meeting which is on Thursday, November 17, 2022.
