Consideration of approval of Transfer of Appropriations No. 22-068 in the amount of \$105,492.00 derived from Fire Department - P&S-CDF Contract to Equipment/Furniture>\$5,000.00 for Fiscal Year 2022-2023.

### **DISCUSSION:**

The Fire Department will be ordering one (1) water tender from Midwest. Midwest is a small company, and typically require full payment of the chassis prior to fabrication. However, as this is the seventh purchase through HGAC, they are working with the Fire Department as they understand our plan to finance. The previous water tender cost was \$323,085. The new water tender cost is \$404,957.

The funding for the down payment is recommended to come from the P&S-CDF Contract. The balance of the cost of the Water Tender will be financed through a lease purchase agreement under the Bank of America Master Lease Agreement that was approved by your Board in July 2020. The down payment will be fully reimbursed by Bank of America after the water tender has been delivered by Midwest.
