DISCUSSION:

On November 1, 2022, your Board approved a Receipt of Unanticipated Revenue No. 22-034 to provide funds to install new shower pads at the Madera County Jail. The purpose of this agreement is to remove the existing floor (VCT) material in the areas outside of the upstairs and downstairs showers at the jail and have the flooring replaced with Stonclad GS which includes a chemically resistant topcoat. The areas impacted will be the hallway exteriors to the shower entry in the following modules: C/D/E/F/G/H/J/K.
