Consideration of entering into an Agreement with California Mental Health Services Authority (1941-HER-2022-MC) in an amount not to exceed \$1,731,082.00 for the participation in the Semi-Statewide Enterprise Health Record for Fiscal Years 2023-2029 and authorize the Chairman and Department Head to sign.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

The California Mental Health Services Authority (CalMHSA) is seeking to create a new multi-county Enterprise Health Record (EHR) system and provide a managed centralized data repository. Through this multi-county collaborative effort, the EHR will support Behavioral Health's core business requirements and address all regulatory requirements specific to the State of California by establishing consistent workflows, configuration, and functionality. CalMHSA will provide centralized application administration, standardized training, and end-user support, and shared technical services. This fully integrated web based EHR system will be specifically designed to manage all aspects of Behavioral Health service provision from managing programs to

billing and revenue management while fulfilling all the requirements set forth by Medi-Cal. The EHR will also include Reporting and Form capabilities that will streamline the required data and other reporting processes.

The term is from the execution of this Participation Agreement through March 18, 2029, with the option to extend the Program for up to three (3) additional years in one (1) year increments. This system has a transition period and will be replacing our current EHR System.

FISCAL IMPACT:

The maximum amount of this Participation Agreement shall not exceed \$1,731,082 over the seven (7) year period. This consists of Committed Funding in the amount of \$1,531,376 which includes the initial deposit of \$181,324 and a Contingency Budget in the amount of \$199,706. The costs associated with this agreement will be offset by MHSA and Mental Health Realignment funds; therefore, there will be no impact to the County's General Fund.

CONNECTION TO THE COUNTY OF MADERA STRATEGIC PLAN - MISSION 2023:

This agreement meets the goal of the Strategic Focus Area of Technology by participating in a new EHR system that would improve documentation and data requirement requirements related to the EHR on behalf of this collaborative.
