## DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

### **DISCUSSION:**

The State Route 41 (SR 41) Expansion project is a cooperative project to widen SR 41 from approximately Avenue 10-1/2 to north of Avenue 15 to four (4) lanes. The project is underway and currently in the design and right of way phases.

The County has entered into a Cooperative Agreement (MCC# 11344-19) with Caltrans to act as the lead agency for the design and right of way phases and will be entering into a future Cooperative Agreement to act as the lead agency for the construction phase.

The project will require acquisition of various parcels along the project limits on SR 41 and also requires various reviews, approvals, and permits with State, Federal and local agencies in order to complete the design and construction of the project.

The project is currently on schedule to complete design in late 2023 and proceed into Construction in 2024, barring any unforeseen delays. In order to ensure that the project remains on schedule, while still adhering to all necessary requirements from the various involved agencies, the Department is requesting that the Board approve the resolution authorizing right of way acquisition for the project and authorizing the Chief of Development Services to execute various agreements, permits, and documents related to the SR 41 Expansion project.

The Department is recommending the approval of the Resolution as presented.

Caltrans, MCTC, Madera Irrigation District, US Bureau of Reclamation, and other State, Federal and Local Agencies

### **FISCAL IMPACT:**

There is no fiscal impact to the General fund as the expenses related to the project are paid for out of the Road Impact Fee program or other funding.
