Consideration of approval for Transfer of Appropriations No 22-080 in the amount of \$7,000.00 from Flood Control – Professional & Specialized Services to Equipment/Furniture> \$5000 for Fiscal Year 2022-2023.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

On October 18, 2022, the Board of Supervisors adopted the Emergency Action Response Plan (EAP) with the passage of the Resolution No 2022-156 and Resolution No 2022-153. The purpose of the Emergency Action Plan is to meet response objectives during a flood emergency. The Madera County Flood Control and Water Conservation Emergency (MCFCWCA) has been awarded a state grant in May 2019. This state grant allows the MCFCWCA the purchase of supplies and equipment for flood emergencies. The amount awarded for this purchase is \$272,000 and it has been extended to December 2022. This funding is 100 %reimbursable to the County.

The carport is in the list of items needed to finalize the purchase for this grant. Since the

cost of the carport was not allocated in the Eqpt/Furniture > \$5000 Account in the current budget for FY 22-23, the Department will need to allocate these funds in this account to complete the purchase with Madera carports. The Department is expecting to complete this purchase before the last week of December 2022.

Staff from the Department has worked with staff from the Auditor's Office and County Administration to expedite the approval process for the P.O to complete this purchase. The staff from the Auditor's office allow us to use the funds from the Professional Services account under the condition that the funds need to be reclassified and a journal entry will be submitted to pay the cost of the carport from the appropriate account.

FISCAL IMPACT:

There is no increase to County cost.

WHEREAS, the Madera County Flood Control and Water Conservation Agency ("MCFCWCA") is a California Public Agency with responsibility for flood maintenance and right-of-way authority within its jurisdiction, and the Board of Supervisors for the County of Madera is the ex officio Board of Directors for the MCFCWCA; and

WHEREAS, California Water Code section 9650 mandates that the future allocation or expenditure of funds by the State for the upgrade of project levees protecting an area in which more than 1,000 people reside be subject to the adoption of a flood safety plan by both the local levee maintaining agency and the county and any city whose residents are protected by the project levee; and

WHEREAS, the Department of Water Resources ("DWR") has made completion of flood safety plans compliant with the requirements of California Water Code section 9650 a key element of the State flood emergency response grant program in which this District has participated; and

WHEREAS, the MCFCWCA has, in cooperation with local public safety agencies, prepared a flood safety plan compliant with the requirements of California Water Code Section 9650.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the MCFCWCA as follows:

1. The MCFCWCA Emergency Action/Flood Safety Plan dated November 2021, having been reviewed by this Board of Directors, is hereby adopted as the official flood emergency response plan by the County as required by law and County staff is directed to integrate these plans into County flood response plans and procedures and to assist as needed with their maintenance.
2. The Representative of MCFCWCA is hereby directed to forward a complete copy of the plan to appropriate officials of the city councils of any incorporated city whose residents are protected by the district levee.
3. The Representative of MCFCWCA is also hereby directed to forward a complete copy of the plan to DWR and the Central Valley Flood Protection Board as directed by California Water Code 9650, and to any other appropriate state and federal agency that may request it.
4. The Representative of MCFCWCA is also hereby directed to bring the plan back for periodic review by the Board of Directors as stipulated in the plan maintenance sections.

WHEREAS, California Water Code Section 9650 states that the allocation or expenditure of funds by the state for the upgrade of project levees that protect an area in which more than 1,000 people reside shall be subject to the adoption of a flood safety plan by both local levee maintaining and counties and cities whose residents are protected by a project levee; and

WHEREAS, the Department of Water Resources has made completion of flood safety plans compliant with California Water Code Section 9650 a key element of its flood emergency response grant program in which County agencies and jurisdictions have participated; and

WHEREAS, the Madera County Flood Control and Water Conservation Agency ("MCFCWCA") within the County of Madera, in cooperation with local public safety agencies, has prepared and submitted flood safety plans to the Board of Supervisors for the County of Madera for review and adoption.

THEREFORE, BE IT RESOLVED by the Board of Supervisors for the County of Madera as follows:

1. The flood safety plans listed below are adopted by the County as required by law and County staff is directed to integrate these plans into County flood response plans and procedures and to assist as needed with their maintenance:

- Madera County Unified Flood Fight Command Manual
- Emergency Operations Plan – Base Plan – MCFCWCA
- Emergency Operations Plan – Base Plan – Lower San Joaquin Levee District
- Geographic Information Systems Flood Emergency Mapping Technical Manual
 - Maps: Unified Flood Fight Command – Foothills
 - Unified Flood Fight Command – Valley Floor
 - Citizen Map – Madera Ranchos
 - North Fork
 - Oakhurst
 - Public Safety Map – City of Chowchilla
 - City of Madera

The Director of Water and Natural Resources for the County of Madera is authorized to distribute adopted flood safety plans to state and federal agencies as needed and to review and approve on behalf of the County of Madera any routine revisions and updates as may be submitted by the levee maintaining agencies.
