Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1). The Department intends to apply for grant funding for Round 2 of the IRWMG program. The Proposal will consist of one or more planning or construction projects that serve to improve Madera County mountain communities.

At this point in time, there are multiple projects being vetted, but staff has not decided which will be in the application. Project types may include, but are not limited to, water storage facilities, water supply improvements, water conveyance facilities, water-use efficiency, water treatment, and water conservation.

The Proposition 1 grant funding opportunity is administered by the California Department of Water Resources (DWR). To fulfill the proposed grant project requirements, a resolution must be passed by the Madera County Board of Supervisors authorizing a designated representative to submit the grant application and execute related documents with the State of California.

WHEREAS, the Board desires now to authorize County officials to prepare the necessary data, conduct investigations, file funding proposals, and execute one or more grant agreements with the Department of Water Resources of the State of California pertaining to Integrated Regional Water Management Implementation Grant under the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Water Code sections 79700, et seq.), and to enter into an agreement to receive a grant for the Madera County Mountain Community Improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Madera, State of California, that:

1. The County Chief Administrative Officer, the Chief of Development Services, and their designees are hereby authorized to make a proposal to the California Department of Water Resources to obtain a Round 2 Integrated Regional Water Management Implementation Grant pursuant to the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Water Code Sections 79700, et seq.), and to enter into an agreement to receive a grant for the Madera County Mountain Community Improvements. The County Chief Administrative Officer, the Chief of Development Services, or designee, is hereby authorized and directed to prepare the necessary data, conduct investigations, file such proposal, and execute one or more grant agreements or any amendments thereto with the Department of Water Resources of the State of California.
