RECOMMENDED ACTIONS:

Consideration to adopt a Resolution amending the schedule of position allocations for County Sheriff's Office – Jail Division.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

On behalf of the Sheriff's Office, the Human Resources Department developed the classifications of Correctional Deputy, Correctional Corporal (POST), Correctional Sergeant (POST), Correctional Lieutenant (POST), and Correctional Captain (POST) to assist the department in retaining current staff and the hiring of new staff. Additionally, the new classifications provide an alternative career ladder for individuals pursuing careers in the Corrections field.

On November 29, 2022, the Civil Service Commission considered and adopted the new corrections class specifications and on December 13, 2022, the Board of Supervisors set the salary for the new classifications.

As a note, the Jail Division's allocation in Exhibit '1' of the attached Resolution Amendment was also updated to reflect the elimination of 1.0 FTE Corrections Director.

FISCAL IMPACT:

The cost to the departmental budget will be offset by the reduction in overtime costs as vacant positions are filled.
